4.2 Deputy Chairman**Paul Byrnes**

Our remote meeting will be held at Surfmoort this year, Saturday at 2pm at the Troop Hall. It will hopefully be a really quick meeting and I promise to not take too much time out of your weekend.

The OBs have reaffirmed the policy that OBs who also have a role as a Region Chair will not be voting as their Region Rep and are required to have another representative of the Region there. This has been the case for a while, but we have not been diligent in enforcing it.

We are looking at appointing two positions to the OBs team in the near future to address the impending implementation of YPR. As a Rover section we are likely the least impacted by YPR. It's nonetheless important that we get out ahead of the change and make sure that our voice is heard as a self-governing section and that we are aware of the requirements of the new program prior to needing to fall in line.

The positions will be a YPR Officer and the YPR Business Change Manager. The Officer will be our go-to person for YPR, both for knowing all there is to know on the new program as well as assessing the impact it will have on our Section and ensuring our views and needs are addressed and respected.

The YPR Business Change Manager is a long-term role and is mandated by Scouts Victoria as an individual to facilitate the change to the new program and engage with the Victorian project leaders in implementation of the program. This role will need to be filled by a younger person, preferably 22 or younger, so they can see the role through to 2021. They will be working closely with the State Commissioner for Transformation (Lachlan Preston) and the other section BCMs. This person would work closely with the YPR Officer for the first year to 18 months.

We are looking at appointing people to these positions, we have some people in mind with an interest in the role, if you have people you want to recommend, please get in contact within the next two weeks by emailing deputy.chair@vicrovers.com.au.

I will be having a crack at the policy book over the next 6 weeks, looking at other options for governance. Drop me a line if you want to lend a hand.

We are establishing a 'pilot project' team to put the above plans into action as part of an ongoing international service project (under guidance of the Scouts Victoria International team). We need to progress the initial plans into a working project, looking at initially six Rovers in 2019 and hopefully growing in following years, investigate funding options and resources (e.g. sourcing computers), promotions and cultural awareness, communicating with our Nepalese contacts, and lots more.

<p>This policy has had its name updated to better reflect its purpose. Its first item has been moved to S-4-0 (future S-1-0) and it now points there. This policy will need revisiting, as it may need to have sections consolidated into other policies and become a major pointer to the specific policies for each sub-committee. Factual changes have been made – for example VRC and State Commissioner Rover Support. Interchange has also been replaced by the VicRovers newsletter (weekly round up). Item 3 in budgeting and report keeping has been altered as its definition was slightly vague and some examples below it could be removed in future updates. Item 6 has been changed to reflect what we think the intent was and the items it refers to no longer exist after the import from legacy. We would like discussion on this point, as we don't have the legacy document to compare it to. 11 Items for the Information of the Victorian Rover Council**11.1 NRC Delegate 2018/19 and Observer for the 2018 NRC Conference**

The NRC Conference is on the 13th to the 15th of January 2018 on the Gold Coast, following Venture. Elections for the position of NRC Delegate 2018/19 and Observers for the 2018 NRC Conference will take place tonight.

11.2 New Requirements for Child Safety and WHS Modules for All Adults in Scouting

Scouts Australia as part of its ongoing commitment to create and maintain high standards of WHS and Child Safety has determined that training on mandated e-Learning modules will be considered current for only 3 years on the anniversary date of first completion. Adults are required to re-complete the "current" module(s) before the 3 year validity period expires. From the beginning of December, those members that completed their WHS and Childsafe Modules 3 years ago will receive an email reminder notifying them that they need to renew these modules.

What you need to do?

When you get this email or login to e-Learning and see that the module(s) requiring renewal are highlighted and the launch button labeled "Renew" (rather than review). You will need to work your way through this module from start to finish, you will then be required to pass the post-test to be awarded the module. The reason you need to recomplete the whole module this time is because there have been significant updates to the content to reflect the changing trends of legislation and community expectations. Down the track it is expected that this renewal process will be simplified to a pre and post-test as the legislation becomes less fluid and embedded into the community.

What happens if I don't renew?

If members do not meet their obligation to renew these modules your Branch/State will then activate its local policy to suspend the member from working with children and potentially terminate individuals memberships from Scouts Australia. It's important to make sure that your Branch/State has your correct email details or you will miss the reminder.

Does everyone need to retest now?

No, but there will be a significant volume of members that will come up for the retest as it was three years ago that these modules were first released as compulsory modules. After this initial phase, the requirement for recompletion will even out.

If I completed this module on the 30 November 2017 will I need to re-sit?

No, you will start receiving reminders to re-complete these modules 30 August 2020. There will soon be a bridging communication available online that bullet points the updates in the module for those wanting to up skill before the renew is due.

Timeline:

- December 2017 – 1st email reminder: Members that completed WHS and Childsafe in 2014 will receive reminder emails to renew these modules. They will have 12 weeks to complete from the first email.
- January-February 2018 – additional reminders emailed: Branches will be reviewing reports that list members that are yet to renew and Branches will be asking members to explain why

this has not occurred.

- March 2018 – Any member that has not renewed will be suspended: Potentially membership terminated.

A big thank you to Peter on behalf of the Bays Region for auditing the Region's books for the last two years.

Cat Houston and her crew catered for the recent Basic training weekend at VRC. The facilities in the kitchen are fairly sub-par and are in need of updating/renovating. Some tracks have structural damage, making them unsafe for racing. The estimated bill for these works is between \$60-80,000 – a bill that will need to be footed/supported by VRC.

SUB COMMITTEES

1. The Sub Committee shall consist of [members as outlined in S-4-0 Sub Committee Eligibility \(S-1-0\)](#)
 2. The Sub Committee Office Bearers may meet as an Executive as required. The ~~Branch Commissioner (Rovers)~~ [State Commissioner of Rover Support](#) and the Chairman of the ~~Branch Victorian~~ Rover Council shall be considered members of the Executive "ex-officio".
 3. The Sub Committee shall ensure that a representative, either the Chairman or Senior Committee Member, is in attendance at each [BV.R.C.](#) meeting to present a report and to answer questions. (Depending on the time of year the [BV.R.C.](#) may grant an exemption to a Sub committee where appropriate.)
 4. A written report detailing the current activities of the Sub Committee, major proposals and current financial statement shall be forwarded to the Rover Office for inclusion in the [BV.R.C.](#) agenda on or before the third Wednesday in the month. (Where a sub Committee has nothing to report, a note confirming this and indicating current bank balances shall suffice.)
 5. The Sub Committee shall have an Annual General Meeting as soon as possible after the completion of its major event. The A.G.M. will be open to all Rovers, and must be advertised [at the event \(if applicable\)](#), in ~~Interchange~~ [the vicrovers newsletter](#) and ~~via the~~ [at BV.R.C.](#) at least two months prior to the date of the A.G.M. ~~The A.G.M. should be advertised at the event.~~ Office Bearers required by the Sub Committee shall be elected by Rovers at the A.G.M. Any Rover present may be nominated for any position at the A.G.M. Where a Sub Committee considers prior experience to be important, or a vote is required to elect a candidate, the person should expect to give a short description of their experience.
- Voting at A.G.M.s to be on the basis of a maximum of two votes per Crew.
- This is a general clause that may be overridden by policies within a Sub committee's operating guidelines, as approved by the [BV.R.C.](#)
- The [BV.R.C.](#) Chairman, or his/her proxy, should conduct the elections.

SKI LODGES

The Bogong Chalet Management Group and the Baw Baw Rover Crew should forward to the Branch Rover Council an annual report within three months of the conclusion of the skiing season, such report to include a list of the Rover Crews represented at the two lodges during the preceding Winter Season.

SUB COMMITTEE BUDGETING AND FINANCIAL RECORD KEEPING

The Sub Committee shall administer the financial accounts for the event on behalf of the [BV.R.C.](#), and shall present a detailed and audited statement of accounts at each A.G.M. In order for the accounts to be audited by the [BV.R.C.](#) Treasurer the complete statements must be submitted at least three weeks prior to the A.G.M. (The [BV.R.C.](#) Treasurer will audit the accounts.)

1. The Sub committee shall prepare a budget for each year's activity and submit it to the [BV.R.C.](#) five months prior to the event. While the [BV.R.C.](#) recognises that Budget estimates are only a guide, major departures from the Budget should be tabled at the [BV.R.C.](#) and a short explanation of the circumstances given.

2. A Sub Committee shall be responsible for setting the costs and charges for an event on behalf of the ~~B~~V.R.C. Any increase in costs or charges to members of the Rover Section beyond 10% from the previous year must be approved by the ~~B~~V.R.C. who will consider the reasons and details put forward by the Sub Committee.
3. Purchases of capital equipment with ongoing maintenance costs by a Sub Committee should be brought to the ~~B~~V.R.C.'s attention prior to purchase.
The Sub Committee may purchase, without prior approval of the ~~B~~V.R.C. any of the following:
 - Non-capital or consumable items essential to the event, such as food, fuel, tickets, posters, office supplies, etc.
 - Capital equipment items considered essential up to \$100.00, to a total of \$500.00.
 - Hire of essential equipment or services.
4. In the case of the Baw Baw Rover Crew, the Bogong Committee, and the Mafeking Rover Park Committee, where the expenditure is essential for the maintenance and development of the Section's capital assets (i.e. the W.F. Waters Lodge, the Bogong Chalet, and the buildings at Mafeking Rover Park) such expenditure shall be exempt from this provision. However, this expenditure should be reported to the ~~B~~V.R.C. at the first opportunity.
5. Where a situation arises that compels a Sub Committee to outlay funds in advance, or to purchase capital equipment in circumstances when consultation with the ~~B~~V.R.C. is not possible, conditional approval may be given on behalf of the ~~B~~V.R.C. by the agreement of the Chairman and Deputy Chairman of the ~~B~~V.R.C. and the Branch Commissioner (Rovers).
6. *Where provisional approval is given under paragraph ~~4~~ 5, or where equipment is purchased under paragraph ~~4~~ 3, the details shall be reported to the following meeting of the ~~B~~V.R.C.*
7. ~~At the completion of the A.G.M. each year, the net profit of the activity shall be forwarded to the B.R.C. Treasurer, together with a detailed request for any float or advance for the following year. After the request has been considered by the B.R.C. the agreed amount will then be forwarded back to the Sub Committee to enable the new Committee to conduct the next event.~~
8. Sub Committees are reminded of the ~~B~~V.R.C.'s policy that wherever possible, activity costs and charges should provide a lower cost to members of the Rover Section than non- members, and that they should consider the policy on "Disadvantaged and/or student Rovers."

MARB 2017: Kickin' It Old School was hosted by Bays Region. The event planning began 18 months before, with a date being set and a venue booked by the end of April 2016. From there the team was assembled and goals were set. 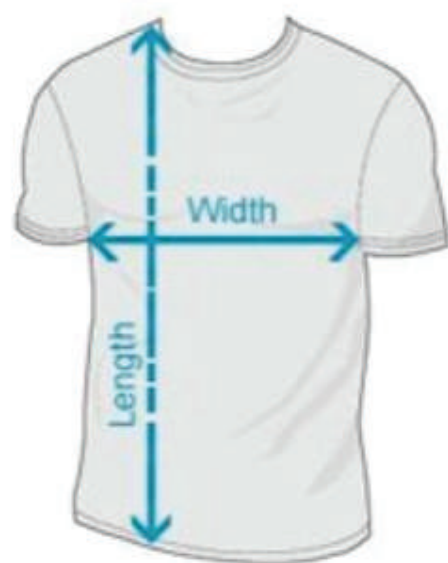

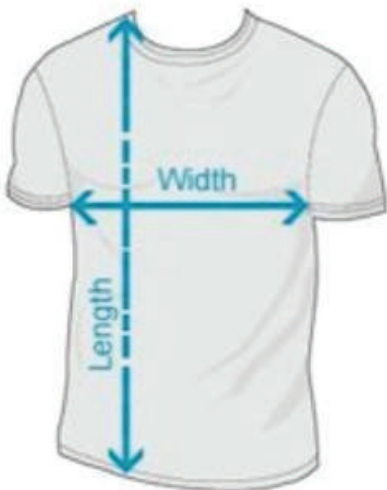

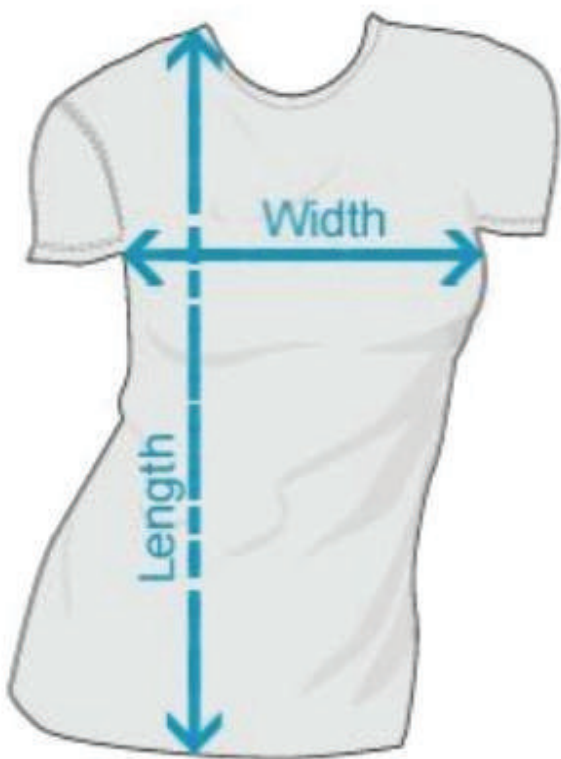

Position Description for Contingent Leaders

Role Overview

Contingent Leaders form an important part of the communication structure between the CBR Moot Organising Council and participants of The CBR Moot, and are the primary point of contact between these parties. For the Contingent Leaders the CBR Moot Administration Director will be the main point of contact within the Organising Team, and will be in regular contact with Contingent Leaders throughout the lead up to the event and at the event itself.

Positions Responsible for

It is recommended that each Contingent also select a Deputy Contingent Leader to assist with the required jobs, and to fill in where the Contingent Leader is unavailable. Other positions should be added where required.

Key Responsibilities

Marketing

To assist in promoting CBR Moot to the greatest number of Rovers possible, we will be seeking assistance from Contingent Leaders to help promote the event to as many Rovers in their state/territory as possible. Throughout the lead up to the event you will be supplied with promotional material from the CBR Moot Organising Council, and you are welcome to add in other material where you see fit. As the first point of contact for Rovers within your state/territory, we would expect you to have a good understanding of information about the CBR Moot so you can keep them informed. This will be assisted through regular updates from the CBR Moot Organising Council, as well as through updates available on The CBR Moot website and social media.

Communications

A key part of the job of Contingent Leader is to facilitate communications between the CBR Moot Organising Council and the participants and other members from their state/territory. The Administration Director, as the Contingent Liaison, will make regular contact with each contingent leader in the lead up to CBR Moot to help keep all participants informed. If you have any issues or questions the Administration Director will be able to resolve or answer them, or keep you informed as to when an answer will be available.

At the event, we will require Contingent Leaders to be contactable at all times in case of any issues relating to their contingent. We will need a contact number from you, as well as a nominated secondary contact.

Your contingent will be supplied with a Moot email address to assist with communications.

Applications

Contingent Leaders are responsible for checking and approving all applications from their Branch before acceptance by the CBR Moot Organising Council. This will involve checking all applicants are current registered members, have correct details listed and are appropriate to be attending the event.

Applications will be able to be checked online through the CBR Moot Event Management System. Further details about this will be available as the system is developed. It is expected that Contingent Leaders will regularly check in on the system to ensure prompt acceptance of all eligible members so they can proceed to the next step of the application process.

Meetings

We would ask all Contingent Leaders make themselves available to attend a number of meetings in the lead up to and during The CBR Moot. There will be online meetings with the Deputy Chairman and other contingent leaders to distribute further information, and daily briefings at the event. We would also ask that the Contingent Leaders then attend meetings within their branch to help distribute information about the event, to assist with promoting the event.

Finance

Often contingents will find it necessary to build a budget for the organisation and management of the contingent. This may be used for the purchase of transport, contingent merchandise or other areas. This will be the responsibility of the contingent, as the CBR Moot will be unable to provide any subsidy for contingent budgets.

Reporting

The Contingent Leader will be required to submit reports on behalf of the Contingent in the lead up to the event, as well as after the event.

Selection Process

It is up to each Branch to determine the appropriate process for selection of their Contingent Leader. If there are any issues or questions, please feel free to contact The CBR Moot Deputy Chairman to discuss them.

The Scout Association of Australia, ACT Branch is Hosting the 21st Australian Rover Moot from 30th December – 10th January 2020. We are currently seeking applications for the Role of Contingent Leader for each State and Territory.

Eligibility Requirements

To be eligible to apply for the position of Victorian Contingent Leader, you will:

- be a registered member of Scouts Australia,
- be a financial member of the Scouts Australia for the duration of the appointment; and
- hold a Certificate of Adult Leadership, preferably in the Rover Scout Section (or be willing to complete the required training in the first six months).

Time Commitments

The Contingent leader will be expected to demonstrate a willingness to devote the necessary time to the role. The Contingent leader must remain an active participant in the broader Rover Scout program.

Contingent leaders will be expected to commit around 5-10 hours per month at the beginning of their appointment with the time commitments increasing as the event draws closer.

The Contingent Leader is expected to advertise CBR Moot within their Branch and thus should attend branch events and weekly Rover nights of multiple crews to promote the event.

The Contingent Leader is expected to attend a training weekend around November 2018 held in Canberra (at CBR Moot's cost).

Skills and Experience

A full position description for Contingent Leaders are attached.

Applicants for this position must be able to demonstrate:

- a commitment to the Aims and Principles of Scouting;
- strong interpersonal and team leadership skills within a volunteer organisation, including the ability to lead, delegate and motivate others;
- appropriate skills in working with peers and other adults to achieve a desired result;
- personal motivation, organisation and administrative skills;
- effective oral and written communication skills;
- ability to achieve tasks within a set time frame; and
- willingness and ability to devote the necessary time to the role.

How to apply

To apply for the position of Victorian Contingent leader, you must send the following to VRC:

- completed application form;
- details of two referees, one of which must be from the Scout Movement;
- your Scout Resume; and
- your usual Work Resume.

All applicants are to use the STAR (Situation, Task, Action, Result) model to address the selection criteria. This method helps you to provide practical examples of how you meet the criteria.

When describing an example of how you meet a criterion, think about:

- What was the SITUATION? What was the circumstance where you used the skills or qualities and gained the experience?
- What was the TASK? What was your role?
- What ACTION did you take? How did you do it?
- What was the RESULT? How is it relevant to the job you are applying for?
