# 4 Office Bearers Reports

4.1 Chair Catherine Marley

It has been a big year for Victorian Rovers, filled with great events, celebrations and the occasional disaster.

We had very successful major events. In September, MARB turned back the clock and danced the night away. Surfmoot got wiggly and enjoyed the surf and sun. Mudbash was too hot to handle, with great racing and even better music. Each of these events were a hit thanks to the committees who put all their time and effort into it. We had record attendance at Mudbash, with over 700 people onsite for the event, and even more on open day.

We attended Winter Gathering, Vic Gathering and Anything Goes, with Rover booths and giveaways. The wrist bands and temporary tattoos were a great hit, and we were about to show off everything Rovers has to offer. We also had a great amount of Rover involvement in these events, with Zoe as the Camp Chief for WG and over 160 Rovers assisting with AG. I'd love to see this kind of involvement continue, it's a great way to improve our Venturer Retention.

We had over 140 Rovers attend Apple Isle Moot in Tasmania in January. This was a great trip, with so many expeditions that showed off the unique attractions Tassie has to offer. Lily and her contingent team did a great job getting everyone there and back again, and looking after everyone in between. We had our first use of the Victorian Moot Buddies program, with support being provided to those who needed financial assistance. This was put to the test when expedition prices rose after the cut-off date for registrations. We were able to assist many rovers with these additional costs, and made sure no one had to pull out last minute. Thank you to everyone who made this happen, it was a very hectic week.

In October, Northern Victoria was hit by several days of flooding. Homes were damaged and belongings were lost. Rovers from Murray Midlands provided support to their local areas, doing recovery work while others tried to organise support from afar. Their help was incredible, and it's wonderful to see Rovers moving so quickly to aid those who need it. They are a true example of Rovers providing Service. Unfortunately, CARB was cancelled this year due to the flood damage, but we hope to see it back next year.

Around the same time we also had some flooding occur at VRC. Broken pipes caused water damage to the main hall and hallways, leading to the temporary relocation of these meetings while the water was cleared up and the carpets were removed. After eight long months, the new carpet has finally been installed. Thank you to the Office Bearers who put in the work over the last two weeks, and to Regi for being the Carpet Expert. VRC looks better than ever.



We supported eleven Rovers and two Rover Advisers in Youth Mental Health First Aid training with a fully subsidised course in December. Since then we have also funded two more Rovers in this training. This has been one of many steps to improve support within the Rover section. The Welfare team has had a busy year, with their first event being Mudbash last year. They have since provided invaluable support at major events to countless Rovers.

In January we hosted the National Rover Conference. It was wonderful to finally meet all the people we had been working with and to collaborate in workshops and plenary sessions. After a year or so of discussion and debate, we also had our voting rights returned to us by the outgoing chair. We promise to use them wisely.

In February we saw the resignation of our State Commissioner, Pete Wotherspoon. It was sad to see him go, as he was a fantastic commissioner, but also a great mentor. He made himself very difficult to replace. Stephen Carter was officially appointed to this position two weeks ago, and is already finding out how much work Pete had on his plate. Nominations are now open for the Assistant State Commissioner role to fill out the team once more.

In March, we held the Mafeking 30th, a wonderful celebration of Rovers and the Park. Almost every chair of the Park was in attendance, sharing stories about the old empty paddock that's become a wonderful tree-filled campsite. This was a beautiful moment to reflect on what we have achieved and where we are going in the future.

We had an array of awards presented during the year, between Adult Recognition Awards at Gilwell Park in August, W.F. Waters Awards at Rover Dinner in October, and Baden Powell Scout Awards at Government House in April. We are submitting the last of the old BPSA awards tonight, and the first of the new system. It's been wonderful to see so many achievements this year, and to hear about the different projects undertaken by Rovers.

This year was also the test run for the Victorian Rover Levy. This was successful from the Rover perspective, with our operating budget being funded from the levy. From a Branch perspective, it is not a viable solution, with one section being charged more than others. Jody, Stephen, Zac and I are currently working on a new financial system to hopefully bring to the table next month. We will be bringing this to the subcommittees and Branch to refine the details in the next couple weeks. I will be staying on to assist with this project and will hand over all other operations to Zac and his new team. This is in line with point ten of the duties and responsibilities of the VRC Chair in the policy book, placing me in the 'Immediate Past Chair' role for three months after the end of my term.

I'd like to finish off my final VRC report with some thank you's. To my executive, who have been amazing all year, with Maddy managing the hell out of the region teams, Rachael going above and beyond the duties of secretary, and Cam and Anthony supporting the subcommittees to put on kickass events and manage the best assets Scouts Victoria has to offer. To the Commissioner team, for always being there for a chat or a rant. Pete has been the constant guiding force to help keep me on track, Regi has been a wealth of knowledge, always there with the right answer, and Stephen, for doing the background work no one sees. To the Office Bearer team, for being enthusiastic and motivated, and being happy to work on anything I threw at them. It's been a big year and I'm proud of the work we have done, all of us. I hope Zac has a smoother term than me, but who knows what the next year will bring. Good luck to the next team, I hope you have fun with it!

Whilst the training officer will remain vacant for the time being, there are still enough of us who sit around this table, and a part of that team that we will be able to manage, and still keep the table updated.



As another Rover year draws to a close, it is an opportune time to reflect on the achievements of the Section over the past year.

We have continued meeting in person as a Rover Council and for our committees, but have also offered the opportunity for people to join remotely. The use of 'hybrid' meeting styles has facilitated members from anywhere in the State to participate fully.

Unfortunately, last (calendar) year, the Rover Centre was flooded due to problems with a leaking cistern and blocked sewer. Not only did this lead to damage to the carpet, but also required considerable work on the electrical system as a result of 'overloading'. This meant that regular meetings for VRC were held off-site in various locations including the Branch Activity Centre. The issues have now been rectified, and the Centre has returned to normal operations. Thank you to all involved in the work at the Centre and to those who re-scheduled meetings over a period of some months. A special thanks to Callan, the Resources Officer.

After being closed for some two years, Mafeking re-opened and was due to celebrate its 30-year anniversary in November, but, due to heavy rainfall and major flooding in the area, the celebrations were postponed until March 2023. Thank you to Charmaine, the Mafeking Committee and all involved for a successful weekend.

Mudbash ran on the traditional June weekend (now the King's birthday) and was very successful with over 700 participants and an amazing 500+ visitors on Open Day. Congratulations to all involved from the Mudbash Committee and others who supported them for the weekend.

Both ski lodges at Mt Baw Baw and Mt Bogong, had a successful year which was wonderful to see, particularly given a two-year hiatus due to COVID restrictions.

Surfmoot this year got off to a somewhat rocky start, but with assistance from members of the VRC Executive, the Committee was able to run a successful event.

RSM ran events throughout the year and provided support to Mudbash. Whilst a few cars came off 'second best' in accidents, fortunately no-one was injured.

MARB and Rover dinner were also successful events – a tribute to those involved in the planning.

It is pleasing to note that interstate and international activities have been well supported. At the end of 2022, a contingent of Victorian Rovers joined others from around the country at the National Rover Moot (Apple Isle Moot) in Tasmania. Given some of the issues with funding and changes to expedition costs, it was satisfying that we were able to support a number of Rovers to attend and enjoy the experience. I would like to acknowledge the



generosity of the CAS Terras team in donating funds to the Victorian Moot Buddies fund. This donation was greatly appreciated and assisted Rovers to attend AIM.

A somewhat smaller team took part in the 1 st African Moot in Kenya. Reports indicate that everyone enjoyed the experience which was 'different' from that of an Australian Moot.

July 2023 will see another group of Victorian Rovers joint the contingent travelling to the International Scout Centre in Kandersteg, Switzerland (KISC) to celebrate the Centre's centenary. I am sure everyone will have a great time.

All of the events, assets and activities would not have run without the dedication and determination of all committee members and the support of the appropriate Rover Advisors. Thank you all.

The VRC Executive team chaired by Catherine and well supported by Deputy Chair Maddy, Assistant Chairs Anthony and Cam and Secretary Rachael, have achieved much and made positive contributions. That the year has been successful is due in large part to continuous efforts of the group. This year saw the introduction of two Assistant Chairs – an arrangement that has worked well and enabled each occupant to participate more fully in committee meetings.

The Officer Bearers team has been amazingly supportive during the year with each portfolio member achieving much within their ambit.

The Rover Training Support Team has continued to operate effectively within the revised training program which is now generic and not Section based. I must especially thank Sue Tanck for her role as Leader Trainer (4 bead Wood Badge) for her incredible contribution over many years with the team. Sue's input and wise counsel has been much appreciated by many over an extended period. Sue has also been a Rover Advisor and will be missed by all. # **SURFMOOT 2024 BUDGET REPORT**

#### **INTRODUCTION**

Surfmoot is an event organised and run for Rover Scouts by the Rover Section of Scouts Victoria. Participants for the event are Rover Scouts, which are adults aged 18 to 26 years. The event is held annually over the Australia Day long weekend at Eumeralla Scout Camp in Anglesea. The upcoming Surfmoot event will be held over four days, starting on Thursday 25<sup>th</sup> January and ending on Sunday 28<sup>th</sup> January, 2024.

The weekend is a social event, with participants having the opportunity to engage in onsite activities or leave site temporarily to explore Anglesea and its surrounds. Surfmoots are traditionally based on a pop culture theme. This year's theme is 'Spymoot'.

#### **BUDGET BREAKDOWN: INCOME**

#### Tickets:

- Three types of tickets will be offered for purchase in the lead up to the event. Early bird tickets will be sold at \$80 and will be cut off on the 1<sup>st</sup> of December. Presale tickets are set at \$90 and will be cut off on Sunday 17<sup>th</sup> of January (1 week before gate opens). Gate tickets are set at \$105 and will be available for purchase during the event.
- The early bird and presale tickets reflect the presale and gate ticket prices from 2023.
- Due to inflation, the committee was considering only having presale tickets and gate tickets at an increased price. The early bird ticket option has been created to have a ticket option that is as affordable as possible.
- The committee has changed the name of the 'New Rover' ticket to '18 Year Olds' ticket. This has been done to prevent confusion surrounding who is eligible for the ticket, as several new Rovers who were over the age of 18 reached out to purchase a discounted ticket in 2023. This ticket price has increased, as it is half the price of the \$90 presale ticket.
- Short stay tickets have had to increase to \$30 as it includes the overnight stay. The 2023 short stay ticket was only a day ticket.

#### **General Store:**

• The committee is not relying on profits from merchandise and tenders to help with our budget. They have been included as line items to indicate possible income. The merchandise income is included to zero out the set-up costs of merchandise listed in expenditure.

# **BUDGET BREAKDOWN: EXPENDITURE**

# **Administration:**

• \$50 will be allocated to cover any potential administration materials.



#### **Entertainment:**

- The overall entertainment expense has remained relatively consistent with the proposed amount in 2023. A slight increase can be seen, which is due to inflation.
- The committee would like to improve the nighttime entertainment, hence why the allocation of funds for talent is significantly higher than other areas. This increase will allow for a greater number of bands and DJs to play over the weekend.

#### Treasurer:

• The treasurer costs reflect the actual costs outlined for 2023. A slight increase has been added to allow for any discrepancies.

#### **Activities:**

- The committee wants to work on enhancing both onsite and offsite activities offered at Surfmoot in 2024. Therefore, we have allocated almost double the amount of funds budgeted in 2023. This increase will allow us to hire groups both within and outside Scouting to offer a larger number of attractions.
- The committee plans to use the same bus service as used in 2023. The cost budgeted for 2024 is based on the actuals of 2023 with a slight increase to allow for any discrepancies.

# **Works & Services:**

- Inflation has caused an increase in the works and services expenses.
- In the past, the Geelong Region has covered the funds of the portable toilets and pump out.
  However, due to an increase in costs, the committee will now have to pay for a portion of
  the toilets and shower fees. Surfmoot will be covering the costs required for the disabled
  toilet.
- In 2023, the size of the skip bin hired for rubbish removal was not big enough. A larger skip will be required, which has been quoted as an extra \$200 than 2023.
- The committee will be booking a site vehicle to use for the 2024 event, which was not done for 2023.

# **Power & Comms:**

Surfmoot received discounted equipment in 2023 due to being provided with faulty
equipment the year prior. After having further issues with this business' equipment in 2023,
the committee has made the decision to no longer use their services. As we will be hiring
elsewhere, we will have to pay full price to hire equipment from other companies. This is
why the 2024 expenses for power and comms are significantly higher than the actuals of
2023.

#### PR & Marketing:

 We have had to slightly decrease funding for PR & Marketing to allow for the increase in other departments.

#### Venue:

- Eumeralla costs have increased from \$5 to \$6 per person each night. Therefore, there has been an overall increase of \$3 per person to cover camping costs over the event.
- The Geelong Region will cover the costs of some buildings for the event.



#### Miscellaneous:

• We have allocated \$300 to capital investments for a point-to-point link, which will help to improve internet for the camp.

# **SCALED SUMMARY**

The scaled summary indicates the possible profit outcomes with differing ticket numbers. The scaled summary is further justification as to why the third ticket option was added, as it reflects how a budget based purely on \$80 tickets would result in a loss of profit.

# **CLOSING STATEMENT**

The committee has worked hard to keep ticket prices as low as possible while accommodating for the inflation of other expenses. We want to work hard to provide value for money when a participant buys their ticket. Last year's feedback showed that we need to focus on better activities and entertainment, particularly in the evening. The budget above reflects how we plan to grow the event to a higher standard both in terms of amenities and things to do.

The budget proposes an overall profit of \$2,026, which is over the minimum 5% profit margin.
