### 1. The Event

### 6. Entries

- Entries will open on the publication of these regulations and close separately at the commencement of each session.
- Entries are open to passengers aged from 12 years on Sunday 10 June 2018.
- Each passenger shall complete and sign the CAMS "Passenger in Vehicle Disclaimer Form" before any test session.
- If the passenger is under 18 years of age their Parent/Guardian must sign their disclaimer prior to participation.
- A maximum of 75 passenger rides will be permitted per session, accepted in order of receipt.
- The Promoter reserves the right to refuse entry in accordance with NCR83.

### 7. Awards

This is a non-competitive event and there will be no results published or awards presented.

## 8. Vehicles & Drivers:

- a) Drivers must hold a current civil Driver's Licence, CAMS L2NS Licence or superior, and a club membership with an affiliated car club of CAMS. This must be presented to scrutiny, along with the vehicle logbook (if issued).
- b) Suitable vehicles will be provided by Rover Scout Motorsport, subject to Scrutiny for safety before the event.
- c) All cars must be adequately muffled to comply with CAMS noise emission requirements.
- d) Fuel must comply with Schedule G of the current CAMS Manual.
- e) All vehicles must comply with Schedule A (refer 'General Requirements for Cars and Drivers' in the CAMS Manual) and with the Group 4H Regulations.
- f) All drivers and passengers must comply with Schedule D of the CAMS Manual regarding apparel.
- g) No competition driving will take place. Vehicles **must** be kept to significantly less than competition speeds.
- h) All drivers must complete a citation lap prior to participating.

## 10. Alcohol, drugs and other substances

- a) Any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may be tested for the presence of drugs (or other banned substances) and subject to a penalty(ies) for a breach in accordance with the CAMS Anti-Doping Policy and/or the CAMS Illicit Drugs in Sport (Safety Testing) Policy as published on the CAMS website. Consumption of alcohol in the paddock, pits or any section of the competition venue/course under the control of the Officials is forbidden until all competition is concluded each day. Accordingly, any holder of a CAMS 'Competition' or 'Officials' licence (or equivalent licence issued by another ASN) may also be tested for the presence of alcohol by a CAMS Accredited Testing Official (CATO) in accordance with the CAMS Standard Operating Procedure for Breath Alcohol Testing.

## 11. Abandonment

The promoters reserve the right to abandon, postpone or cancel the meeting in accordance with NCR 59.

## 12. General

A verbal warning must be given at the time the indemnity is signed to the passenger. The organiser should ensure that they: -

- a) Verbally advise the passenger that accidents can and often do happen and that motor sport is dangerous; and
- b) obtain from the participants a verbal acknowledgement:
  - i. that accidents may happen, and
  - ii. the possible extent of injuries and that they appreciate the likelihood and nature of these injuries.
