



Supplementary Regulations – Requirements for Roverkhana
Event permit number:

1. The event

- a. The Roverkhana Motorkhana event, hereafter shall be referred to as Roverkhana, is a club-only event.
- b. Roverkhana does not form any part of the Rover Scout Motorsport Championship Series for 2017/18 or overall Mudbash results.

2. Place and Date

- a. Roverkhana will be conducted at Mafeking Rover Park on Saturday 9 June 2018.

3. Entries

- a. Entries will open on the publication of these regulations and close at 9am on Saturday 9 June 2018.
- b. Entries will only be accepted from current members of Rover Scout Motorsport.
- c. CAMS licences must be presented at check in.
- d. The competitive entry cost will be \$5 per driver.
- e. The maximum number of entries will be 25 Crews or 250 drivers, accepted in order of receipt.
- f. Entry forms are to be completed in full, including signatures.
- g. All entries that have been accepted will be notified in writing and if required, any further regulations may be sent out at the same time.
- h. The promoter reserves the right to refuse an entry in accordance with NCR 83.

4. Insurance

Certain public, property, professional indemnity and personal accident insurance is provided by CAMS in relation to the event. Further details can be found in the CAMS Insurance Handbook, available at www.cams.com.au.

5. Classes

- a. There is 1 class: Production Motorkhana

6. Starting Order

- a. Competitors shall be advised of the starting order prior to the event.
- b. Vehicles will start Roverkhana from a stationary position, within the start garage in a forward facing direction.

7. Competitors

- a. All drivers that are participating in Roverkhana must be the holder of at least a CAMS level 1 competition licence.

8. Driver's Briefing

- a. It is compulsory for all drivers to attend the driver briefing.
- b. The briefing shall be conducted at 9am.

9. Scrutiny

- a. Scrutiny will take place at Mafeking Rover Park on Friday 9 June 2017 from 7pm.
- b. All competing vehicles must comply with schedules A and Group 4H of the CAMS Manual.

10. Competition and Layout

- a. Roverkhana shall commence at 9am on Saturday 9 June 2019.

11. Awards

- a. A trophy will be awarded to first, second and third outright.

For Competitors

I/We being the entrant/s of the vehicle described on this Entry Form wish to enter that vehicle for the above event.

For Competitors and Drivers

I/We being the competitors and or drivers, certify that the particulars on this form are true and correct in every particular, to the best of my/our knowledge and belief. I/We declare that I/we have read and understood the Supplementary Regulations issued for the event, and agree to be bound by them and the provisions of the National Competition Rules of the Confederation of Australian Motor Sport Limited ("CAMS"). In exchange for being able to attend or participate in the event (including entering the event), I/ we agree:

- to release CAMS and Australian Motor Sport Commission Ltd, promoters, sponsor organisations, competitors, entrants, land owners and lessees, organisers of the event, their respective servants, officials, representatives and agents (collectively, the "**Associated Entities**") from all liability for my death, personal injury (including burns), psychological trauma, loss or damage (including property damage) ("**harm**") howsoever arising from my participation in or attendance at the event, whether caused by the negligence of any of the Associated Entities or otherwise;
- to indemnify the Associated Entities and each of them from any loss, liability damage or cost they may incur arising out of or related to my attendance at or participation in the event, whether caused by the negligence of any of the Associated Entities or otherwise;

- that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Associated Entities, including negligent rescue operations and is intended to be as broad and inclusive as is permitted by law and that if any portion thereof is held invalid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.
